# UNITED STATES IMMIGRATION INSPECTION NOTICE BAR HARBOR- AUGUST 26, 2022

United States Customs and Border Protection (USCBP) requires that <u>ALL GUESTS</u>, regardless of nationality, will be seen & inspected in person by the officials as part of our arrival clearance in Bar Harbor.

# PLEASE READ THE BELOW IMPORTANT INSTRUCTIONS ON TIMES AND LOCATIONS

The immigration clearance procedure will start shortly after arrival at approximately 8:00am, or as soon as the officials are ready to commence. To avoid congestion and to facilitate a safe and smooth flow, we will be calling guests based on their HAL Shore Excursions departure time and for our guests going ashore independently, we will be calling guests by deck number.

Please listen carefully to the announcements made over the ship's Public Address system.

### **INSPECTION LOCATIONS & DOCUMENTS REQUIRED**

#### FOR ALL UNITED STATES CITIZENS

ALL United States citizens must proceed to the <u>World Stage</u>, Deck 2 forward. Entrance will be via the starboard side only. Ensure that you have the following prepared and ready to present:

- Stateroom key card to scan as you enter the lounge
- Your passport (open to the picture page)

## FOR ALL NON-US CITIZENS (ALL OTHER NATIONALITIES)

All non-US citizens must proceed to the <u>Dining Room</u> on Deck 3 Aft. Entrance to the inspection will start from the MIDSHIP ATRIUM Deck 3 area only. Ensure that you have the following prepared and ready to present:

- Stateroom key card to scan as you enter the inspection site
- Passport open on the photo page
- Alien Registration Card (Green Card) for U.S. Permanent Residents

Once you have cleared immigration, your stateroom key card will be marked with an identifier by a member of our staff upon exiting the inspection location.

For all independent guests who wish to go ashore after the inspection, tender ticket distribution will be at the BB Kings Blues Club on Deck 2. You may then proceed to any public area or lounges while waiting for your tender ticket number to be called.

#### IMPORTANT REMINDER FOR ON BOARD CLEARANCE

This face to face inspection is mandatory for ALL guests whether you plan to go ashore or remain onboard during our call. To expedite the inspection process, please ensure you have all the required documents ON HAND prior to entering the inspection location.
