 - Starts in 2024 – 6 month grace period



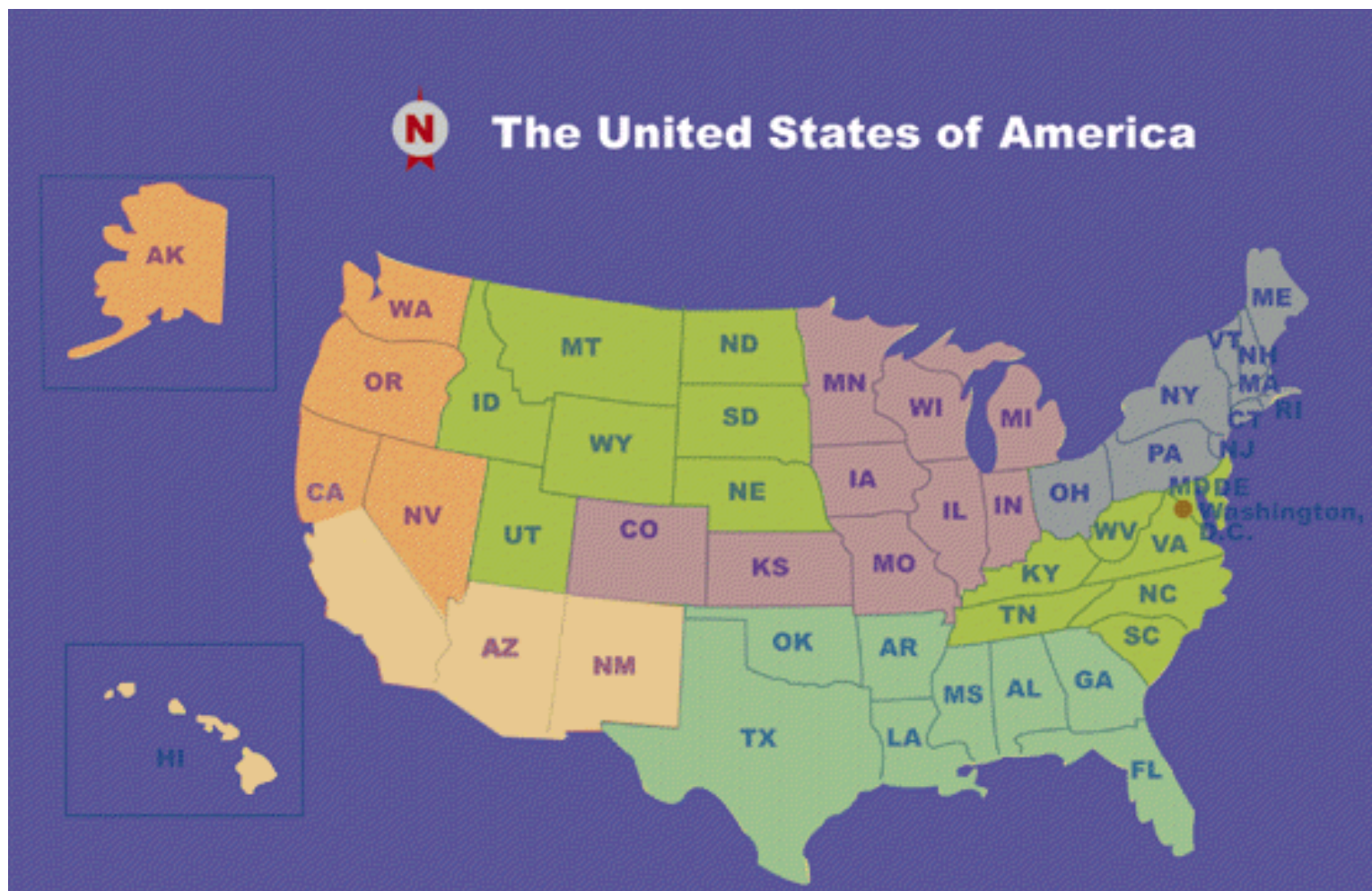
CHINA VISA

CHINA (USA Citizens)

- Consulate Fee \$185
 - CIBT Fees (others similar)
 - \$185 Normal Processing
 - \$450 Premium Service
 - No extra fee for self-service at Consulate
 - 4 working days for Consulate to process the visa – ONCE THE CONSULATE RECEIVES YOUR APPLICATION

CHINA VISA

Tourist Visa Documentation Required

- Passport (6 months remaining)
- Passports with current visa if in a different passport book
- Photocopy of Passport BIO page
- Signed Visa Application
- Proof of residence – to show you are applying at the correct consulate
 - Drivers License with current address – or utility bill etc
- Photocopy of previous VISAs
- Where you stay Form (Certifies you are in the USA)
- Cruise Ticket with Itinerary

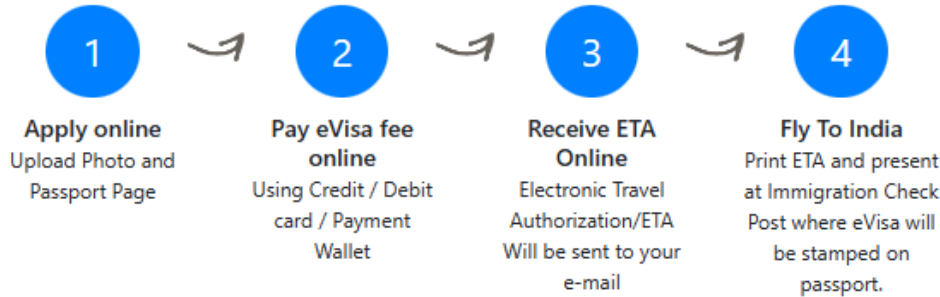

E-VISA APPLICATION PROCESS



Advisory

Government of India makes no provision of charging of any emergency fees or additional fees for grant of any emergency / express e-visa.

Those travelling to India are also advised to go through instructions available on the website of Bureau of Immigration at <https://boi.gov.in>.

eVisa is admissible only under the following categories:

1. e-Tourist Visa
2. e-Business Visa
3. e-Conference Visa
4. e-Medical Visa
5. e-Medical Attendent Visa
6. e-Emergency X-Misc Visa

If the applicant is unable to complete his e-visa application form, he may save the application and may return to complete the application form by clicking the tab at the bottom of page:

After your eVisa applications is submitted, the same shall be scrutinized and if any Document/Image is not appropriate, you may be advised on your given e-mail to re-upload the same. To re-upload use the tab at the bottom of the page. Applicant should normally receive this mail within 24 hours.
